Subject: Monthly allocation of foodgrains for AAY, BPL and APL categories under Targeted Public Distribution System (TPDS) for the year 2011-12 - reg.

Reference : Ministry of CA,F&PD's letters No.1-1/2011-BP.III (1 to 35, except 34) dated 25th February 2011 (allocation i.r.o. all states/UTs except Lakshdweep) (copies of relevant allocation orders are enclosed)

Kindly refer to the communications cited.

Ministry of CAF&PD vide letters dated 25th February 2011 (referred) has communicated monthly allotment of wheat and rice for AAY, BPL and APL families under TPDS for the period from April 2011 to March 2012 in favour of all the States/ UTs (except Lakshadweep).Details of the monthly allocation are given in the attached statement. Copies of the relevant allocation orders of the Ministry of CAF&PD are enclosed.

The Validity period for lifting of these allocations will be fifty (50) days for each allocation month separately, starting from the first day of the month preceding the allocation month and ending on the 20th day of the allocation month. It will be mandatory for State and UT Governments to deposit the cost of foodgrains to FCI latest by 15th of each allocation month (crediting the amount to the FCI account). However, lifting of foodgrains in instalments against allocations within the validity period will be allowed. Beyond 15th day of the allocation month, the Field Officers of FCI will not accept payment from the State/UT Governments for issue of foodgrains during the allocation month. (Detailed instructions have already been issued in this regard vide Ministry's letter No.1-2/2007-BP-III doted 21st February, 2008.)

You are requested to take action accordingly.
