**Subject : Regularization/Writing-off of Storage & Transit Shortages – Review
of Delegation of Powers**

The matter of reviewing the delegation of powers vested with various authorities for regularization/writing-off of storage and transit shortages has been under consideration of the Food Corporation of India for quite some time past, consequent upon the recommendations received from the Standing Committee on Food, Civil Supplies & Public Distribution on Demands for Grants and also that of M/s RITES Limited. In pursuance to the decision taken in the 303rd & 303rd (Adj.) meeting of the Board of Directors held on 29th September, 2006, the modified delegation of powers is as under :

2. The Empowered Committee of EDs shall meet as frequently as possible but at least once in three months.
3. All other instructions on the subject issued from time to time shall remain unchanged.
4. The above revised delegation shall be applicable to all the cases of storage & transit shortages occurring on or after 1.11.2006.
