- ii) Those who have represented combined University team in one of the above discipline in the National and world universaid International competition in the year immediately preceding their application for recruitment in the corporation and/ or
- iii) Those who have represented a State in the National Competition in one of the above discipline in the year immediately preceding their application for recruitment in the corporation and/ or
- iv) Those who have represented in any International Competition in one of the above discipline in the year immediately preceding their application for recruitment in the corporation and/ or
- v) It may be noted here players who have represented the country in the Indian National Team or in the Combined university teams in the International events shall be given preference

4. **General Condition**

- a) Employee of the Central/State Govt. / public enterprises should forward their application through proper channel to reach the corporation before the last date notified below, dicer application should not be considered.
- b) The Corporation may its discretion relax qualification and age in appropriate cases in the accordance with the rule.
- c) More submission of application and fulfilling the eligibility condition would give no right to any person for interview/selection.
- d) All appointments will be subject to rule and regulation of the corporation and /or directives of Govt. of India, inforce from time to time.
- e) The above mentioned post IDA pattern pay scale and usual allowances thereon such as CCA, HRA, Leave, Medical facilities, Travel facilities etc.

5. **Age Limit** (i) Relaxable by 5 years for SC/ST candidates and 3 years for OBC candidate.(ii)Age is further relaxable 5 years for departmental candidate. if otherwise eligible( maximum 10 years in case of departmental SC/ST candidates and 8 years in case of departmental OBC candidates .

6. Self attested photocopies of all documents in proof of age, qualification, experience, caste, etc. should be attached with the application. Original Certificate will however, be called for and scrutinized at the time of final selection. Any attempt to influence the corporation in any manner would disqualify the candidature. Selected candidates will have to execute a Bond for serving FCI Minimum period of 5 year.
