

In pursuance of Hon'ble Supreme Court judgment dated 17.02.95, the Union's election in FCI was required to be conducted under the overall supervision of CLC© Organization but due to constraints of staff/ the divergent views, this matter was decided by Hon'ble Delhi High Court vide its order dated 05.11.08 that the election be conducted with the help/supervision of retired officers of CLC© organization. The Trade Union's Election was held in March 2009 through the duly nominated retired officers of the CLC© and based on the results, the following Unions have been recognized on 3 tier basis i.e. National/Zonal/Regional Levels:-
